

Information sheet

The Faculty Toolkit is a collection of free and reduced-price multimedia software tools that instructors on all University of Minnesota campuses now can download from a Web site. The tools must be used for University course development and instructional purposes. The kit is co-sponsored by the Office of Information Technology (OIT) and the Office of the Senior Vice President for Academic Affairs and Provost and developed and managed by Academic and Distributed Computing Services (ADCS) and the Digital Media Center (DMC), units of OIT.

Recipients

Faculty members

The Faculty Toolkit software is provided once per year for no charge to any faculty member who meets these three criteria:

1. He or she is paid through the University of Minnesota payroll.
2. He or she is in one of the following classifications:
 - 9401 Professor
 - 9402 Associate Professor
 - 9403 Assistant Professor
 - 9404 Instructor
 - 9410 Regents Professor
3. He or she has a tenure-track appointment.

Others

University of Minnesota teaching assistants and employees who do not meet the criteria above may purchase the Faculty Toolkit software for the prices shown that reflect University-wide volume purchases.

Requirements

1. Each recipient must
 - fully complete an agreement form and have his or her department head or manager sign it;
 - provide a course number and title for each software tool requested (unless paying);
 - obtain only ONE Macintosh or Windows version per each request; and
 - have a DVD player and burner to access/install all software.
2. Prices include one year of maintenance.
3. Recipients may request upgrades by submitting a new agreement form. Follow the application instructions below.

I agree to return all copies of Faculty Toolkit software that I have obtained from ADCS when my employment at the University of Minnesota ends, or if the University of Minnesota discontinues its license for my Faculty Toolkit software, or at the end of the term of my license for use of Faculty Toolkit software. At that time, I also will destroy any Faculty Toolkit software backup copies I have made, whether on diskette, hard disk, or any other medium.

If I choose to use Faculty Toolkit software at home, I agree not to allow access to the product by anyone when the product is removed from University premises. I further agree that my home use of Faculty Toolkit software only will be for activities related to my University of Minnesota employment, not for any commercial activities. Faculty Toolkit software will be distributed only to University of Minnesota faculty and staff members.
